Notes	<p>'Adult Education or ESL', 'Short-Term Career Education', 'Degree/Transfer', 'Undecided/Other', 'Strong Workforce Program' Journeys are those that correspond to General Admit Students, and only use that part of the calculation. 'K12 Dual Enrollment' Journey only uses the corresponding part of the calculation. The 'All' Journey is calculated using both parts of the calculation.</p> <p>Students need to have completed a total of at least 12 units in the timeframe up to and including the selected year at any California community college. In the new SCFF, it is required that the 12+ units are earned in the district in the selected year prior to transfer.</p> <p>For students who have taken a mixture of classes at colleges on semester and quarter systems, quarter units will be multiplied by 2/3 to equate to semester units for colleges on semesters, and semester units will be multiplied by 3/2 to equate to quarter units for colleges on quarters</p> <p>Per the MIS DED for SX03, by eliminating 8888 and 9999 values for SX03, the following sections are excluded :</p> <ul style="list-style-type: none"> <li>• Any noncredit section where CB04 = N</li> <li>• Any credit section where CB04 is in (C,D) and where SX04 is reported as "UG", "UD", "W", "MW", "DR" or "SP"</li> </ul> <p>Any credit section where CB04 is in (C,D) and where SX04 is reported as "I*", "IP", and "RD"</p> <p>Metric will not be displayed on the dashboard but will the student universe for 750S Transferred to a Four-Year Institution, 714S Transferred to UC/CSU, 715S Transferred to an In-State Private, 716S Transferred to Any Out-of-State</p>
